## **FIRST STATE DISPOSAL (FSD)**

FSD has launched a Yard Waste Program and will provide a tan 95 gallon yard waste container upon request. Customers can then schedule yard waste pick-up, which will be run on a bi-weekly schedule. You can schedule your pick-ups by telephone, email, or fax. Email is encouraged and will be checked frequently throughout the day. Pricing is \$4.00 per pick-up with your tan container. Should you have excess, brown paper yard waste bags will be accepted alongside your container at an additional charge of \$1.00 per bag.

Complaints about dogs and cats running loose in the neighborhood and owners walking dogs without cleaning up after them is a never ending complaint. State and County laws state that dogs must be licensed, leashed, and cleaned-up after, and under control at all times. Cat owners should be aware that free-roaming cats are at risk. Cats are subject to poison by chemicals used on lawns, by rodent bait, and by antifreeze leaking from cars. They may be tortured or killed by a sick individual, or stolen and sold to research laboratories. Studies have documented the serious impact of free-roaming cats on the populations of birds and small mammals.

## **DELMARVA POWER— EDGEWATER ESTATES**

To improve electric service reliability in Edgewater Estates, Delmarva Power will begin upgrading the existing underground electric cable and replacing some of the pad-mounted transformers (green boxes) throughout the development. We will begin the project in mid-March of this year and, depending on weather, hope to finish the majority of our work by June 2012. Over the last several years, Delmarva Power replaced some of the older cable in Edgewater Estates but has determined that the remainder of the original cable needs to be replaced. Much of it is cable that was installed when Edgewater Estates was first developed.

To minimize disruption, we will use a boring or tunneling technique as much as possible, but some areas will need to be dug or trenched. Following the cable installation, Delmarva Power will conduct property restoration and clean up any disturbed areas.

Delmarva Power's contractor, East Coast Underground, will install the cable and transformers. Following the cable installation, Delmarva Power line crews will perform the conversion to the new cable and transformers. These conversions will necessitate planned outages of several hours. At least 48 hours prior to the conversion, Delmarva Power crews will verbally notify customers who will be affected by an outage. Door hanger messages will be used for customers not at home.

## **POLITICAL SIGNS**

Edgewater Estates Covenants prohibits erecting business signs and notices of advertising, however, political signs may be erected up to 30 days during an election. In 2007 the state Legislature amended existing legislation to protect homeowners' and condominium residents' right to fly flags and display political signs. The revised statute (25 Delaware Code Sec. 81-320) says condominium residents or homeowners cannot be prohibited from displaying a U.S. flag up to 3 feet by 5 feet, and that any rule regarding the flag's display must be consistent with federal law. Unless addressed in the original property declaration, no rule may ban political signs for candidates or ballot questions, but a homeowner's association can restrict the time, place, size, number, or manner of the displays.



## **NEIGHBORHOOD WATCH SECURITY TIPS**

- If you park your vehicle in the driveway, keep the windows closed and the doors locked.
- Keep garage door closed and locked. Keep the door from the garage into your house locked.
- Be sure your street address number is large, clear of obstruction, and well lighted so police and other emergency personnel can find your home quickly.
